

## Dear Petition Nominee:

Thank you for your interest in becoming a potential member of Redstone Federal Credit Union's Board of Directors. We appreciate your participation and interest. In February 2021, three director positions will become vacant.

Below you will find the necessary information required by Redstone Federal Credit Union® (RFCU®) to complete your nomination by petition. These items must be received at RFCU **postmarked by midnight, or hand delivered** by 5:00 p.m., at the Wynn Drive Office on **Monday, December 7, 2020.** 

- 1. A brief statement of qualifications and biographical data.
  - This should include your full name and any information you feel properly describes yourself and what your qualifications are, through employment, community work, clubs, etc. This statement should be limited to a maximum of 250 words. However, please note that due to space limitations on the displayed election posters, your information may be edited.
- 2. A notarized, signed letter of agreement stating you are willing to serve on the Board of Directors of RFCU if elected.
- 3. A signed petition with at least 500 signatures of primary RFCU members.

Please use the form provided in this packet as your petition. Feel free to make copies of the form as needed. All of the information on the form must be completed for each signing primary member. When obtaining the needed signatures, please keep in mind that the signature, telephone number and address must be legible. If the entry cannot be verified, it will not be considered in the final count of required signatures. *Obtaining signatures within 30 feet of the entrance of any Redstone Federal Credit Union building, ATM, or drive-up, or otherwise disturbing the membership and daily business of the Credit Union, is strictly prohibited.*
